THE Party of the First Part of the Trust Deed is empowered to execute the trust deed on behalf of the other remaining trustees.

WHEREAS the name of the Trust may be called as RAJ NAVAL TRUST, GULBARGA, and whereas the FOUNDER TRUSTEES are desirous of settling sum of Rs. 200/- (Rupees two hundred only) each respectively totalling Rs. 1,000/- (Rupees one thousand) only, upon Trust for the objects of this Trust Deed.

AND WHEREAS in pursuance of such desires and for carrying out such desire into effect, the Founder Trustees, hereby all agree to act as "TRUSTEES" alongwith other trustees appointed from time to time. As per terms hereinafter mentioned in this deed and we hereby all declare to have accepted the office of Trustees for life time which we by our executing this deed have testified to.

AND WHEREAS prior to the execution of this deed we hereby declare (and acknowledge) that the sum of Rs. 1,000/- (Rupees one thousand) has been received by us as trustees and have accepted the same subject to the objects of the TRUST.

NOW THIS DEED WITNESSETH THAT:

IN pursuance of the said desire and for

carrying out such desire into effect the FOUNDER TRUSTEE both hereby grant, transfer and assign upto the said TRUSTEES and the said sum of Rs. 1,000/- (Rupees one thousand) only, and all the estate, right, title and interest, claim and demand of the FOUNDER TRUSTEES unto and upon or out of the said sum TO HAVE AND TO HOLD the said sum unto and to the use of the said "TRUSTEE but upon and subject to the TRUST POWERS and provisions hereinafter declared and expressed hereto as follows:-

1. FOR the consideration aforesaid they, the said TRUSTEES hereby will stand and be possessed of the said sum of Rs.1,000/- (Rupees one thousand) only and the investment for the time being representing the same and all, fund and securities and other movables and immovable properties which may be under the TRUST and provision of this DEED be substituted or added in due execution of the TRUST and powers of this DEED and expressly, including any donations or bequeeth by WILL which may be received by the TRUSTEES, all of which are hereinafter in this DEED designated as the "TRUST FUND" upon trust of the use and with the subject of the powers, provisions, directions and the SCHEME OF THIS TRUST as agreed and declared in this DEED.

2. THE said Trustees shall stand and be possessed of the said TRUST FUND upon trust to receive the interest and other income thereof and threout in the first place to re-imburse themselves or pay and discharge all the costs, charges and expenses incurred in or about or incidental to the administration or execution of any of the trust or powers of this deed and also outgoings, taxes, assessments, dues and other taxes payable in respect thereof and the cost of meeting ordinary repairs of any immovable property, if any for the time being subject to the term contained in this deed and SUBJECT thereto and other income and act their description to apply to the whole or any part or parts of the corpus of the trust fund for such purpose including:

3. TO establish and run RAJ-NAVAL BAUGH and construct community hall etc., (which shall be helpful for social, religious, educational and cultural activities), and meeting the first and main aim of this trust, the residue be utilised for the following purposes:

- a) For Education.
- b) Medical Treatment
- c) Religious activities - donating funds for preaching the principles of Jainism.
- d) Social upliftment of needy people.
- e) To help all the sects of Jainism.
- f) To help for Social and Cultural activities of Kannada, Gujarati and Marathi languages.

4. THE distribution of funds shall be as under:-

- a) 10% for running and maintenance of the Trust.
- b) 10% to be ploughed back to enhance the corpus of Trust.
- c) Balance 80% should be utilised for the above aims and objects mentioned at Sl.No. 1 to 6 preferably to utilise 40% for giving direct help to the decedents of Navalchand Mehta Family and balance first preference to any member of Digamber Jain community and then to any member of Jain Samaj and then General.

5. AND Generally all advancement of any other object of religious, cultural or social utility as the Trustees may think fit and in such manner as the trustees may think fit and in such manner as the trustees may think and for one or more of such purpose to the exclusion of other or others as the trustees may think fit.

6. PROVIDED always also without prejudice to the generality of the foregoing that the help to be given under any of the foregoing heads, whenever the case admits, may be given either in the ways pecuniary or by donation, or by interest free loan or nominal interest loan or in any manner

which the Trustees may consider desirable.

7. PROVIDED further that if the trustees deem fit may dispose off RAJ NAVAL BAUGH and the Trust Funds may be utilised for other objects of the Trust, as mentioned above.

8. THE Trust hereby established shall be designated and designed as RAJ NAVAL TRUST, GULBARGA, and the said name shall never be changed.

9. THE Office of the Trust shall be at 1-22, Court Road, Gulbarga, or at such other place in Gulbarga as the Trustees may time to time think fit.

10. ANY of the Trustees hereby constituted or any of them or the Trustees or Trustee appointed from time to time, may at any time resign his office as Trustee by giving one month's notice and upon the expiry of such period, such trustees shall be deemed to have vacated his office.

11. IF the Trustees hereby constituted or any of them or the Trustees appointed from time to time shall die or desire to discharge or refuse or become incapable to act as Trustees or is adjudicated insolvent or convicted of a criminal offence involving moral turpitude and

punished with imprisonment extending six months or be absent from India for a period of twelve months or more without obtaining the leave in writing or absconding for a period of three months or more without intimating his whereabouts, then such trustee/trustees shall be deemed to have vacated his office.

11 (a) WHEN any of the Trustees hereby constituted or any of them or the Trustees appointed vacated or is deemed to have vacated his office, the Trust fund shall become vested in the new Trustee or Trustees jointly with the other Trustees as the case may be and every such Trustee or Trustees shall have the same powers as if he or they had been originally named trustees or trustee of this Trust fund.

11 (b) EACH of the Trustees hereby constituted or any of them in the Trust appointed from time to time binds himself and his heirs, executors and administrators and nominees, in the event of his retiring from or ceasing to be a trustee or in the event of his death to do all necessary acts, deeds and things for duly vesting and transferring over into the name or names of the new trustees or trustee as may be required for the said trust fund and/or securities and deposits, properties, movable and or immovable etc., belonging to the Trust as may be standing in his individual name or in his name jointly with that of other Trustees and all costs attending the same shall be borne out of the income of the Trust Fund

SCHEME OF THE TRUST

12. TRUST FUND:

The Trust fund shall mean and include any donation, gifts, bequeaths and movable and immovable properties for the establishment of the Trust.

13. MANAGING COMMITTEE :

The Managing Committee or the Executive Committee shall consist of the Founder Trustees and they shall elect one of them as Chairman for the period of 5 years of majority votes. For the first five years No. 3 Chanchaladevi shall be the Chairman.

13(11). The number of Trustees shall never be more than 9 and less than 5.

14. SECRETARY OR MANAGER:

The Chairman in consultation with the other Trustees shall appoint a paid or Honorary Secretary or the Manager for the purposes of running the day to day affairs of the Trust and to fulfil the objects of this Trust.

15. The Trustees shall make appointments of
Chartered Accountant/Chartered Accountants as
"Auditor/Auditors" at the annual General Meeting.

15 (a) The Trustees shall maintain regular accounts of the receipts and expenditure of the Trust.

15 (b) The bank accounts shall be opened in the name of the Trust and same shall be operated by the Chairman and one of the Trustees, or any two Trustees.

16. THE annual general meeting of the Trustees shall be held once in a year and such General Meeting shall also direct the Chairman and the Secretary to carrying on the activities of the Trust according to the objects.

17. THE Quorum of the General Body Meeting shall be (3) three.

17 (a) THE Trustees may dispose off any question by circular signed by majority of the Trustees.

18. THE Trustees shall frame the rules for Special General Meeting and Extra Ordinary General Meeting.

19. THE Trustees shall have powers to purchase, sell or accept the movable and immovable properties and to carry out all financial transactions under the joint signatures of the President and Secretary or any two trustees in persuance of the Resolution passed to that effect by the Trustees.

20. IN case necessity arises the Trustees shall have power to convert this Trust into a public trust with suitable amendments to

deed. It is made here clear that out of the (5) five trustees, there shall be atleast (2) two trustees from the discendents of Sri Navalchand Nanchand Mehta family.

21. THE Trustees shall have powers to accept and appoint any other suitable person as trustee in case any post becomes vacant, or in case the Trustees deem it necessary to add more than five trustees, they can do so for such persons who are helpful for carrying out the aims and objects of this Trust.

22. IF the situation arises in the extra ordinary circumstances to dissolve the Trust and if the Trustees are desirous of handing over the said trust fund and if accumulated income to any other trust, having similar objects and aims; they shall be entitled to do so on such terms and conditions as they think fit but such decision to that effect shall be taken by conveying extra ordinary general meeting. Such resolution or resolutions shall be confirmed with the sanction of atleast four trustees or with 2/3rd majority, if the number of trustees is more than 5. The absent trustees can send their definite vote through post or by any message in writing.

23. IF and when the necessity arises to amend the constitution, the same can be done by 2/3rd majority of votes of the total number of trustees.
24. IF and when the necessity arises to amend the rules and bye-laws for administration of this trust the same can be done by the majority vote of 51% of the total number of Trustees.
25. THE Trustees may appoint committee or committees, if necessity arises, for carrying out or implementing different objects and aims of the trust, by separate committees, provided that atleast two of the trustees shall be the members of such committee or committees.
26. IN this deed words imposing singular shall include plurual and vice versa. And words imposing masculine general shall be inclusive of feminine and vice versa.
27. THE Indian Trust Act shall be applicable to this Trust whenever it is not contrary or conflicting with this Trust Deed.


